#### WHAT IS EXCLUSIONARY COVERAGE?

It is the best repair coverage beyond the factory warranty that you can get.

It's called Exclusionary because it is easier to list what is not covered- **excluded** - than to list *everything that is covered.*

- You avoid disruptions to your personal budget when an unexpected covered repair occurs.
- You can finance the cost of the contract in your monthly payment for even more budget control.
- Substitute transportation keeps you with an uninterrupted way of getting around when you have a qualified repair.
- Your service contract is transferable and adds value to your vehicle should you sell to a new owner.

#### SOME EXCLUSIONS

##### What is not covered?

- **Routine maintenance items** such as: oil, coolant, fluids, refrigerant and others.
- **Items that occasionally need replacement** such as: battery and cables, lights and bulbs, tires, brake pads, brake drums, brake shoes, exhaust system, shock absorbers, and strut insert cartridges.
- **Appearance concerns and exterior items** such as: bright metal, vinyl, wheel covers, ornaments, and paint.
- **Interior items** such as: upholstery, buttons, carpet, door and window handles

#### Trip Interruption

When a covered breakdown disables your Recre-ational Vehicle and the covered repairs are com-pleted more than 100 miles away from your resi-dence, we will reimburse you for lodging and meal expenses incurred while covered repairs are being completed. See your service agreement for addi-tional details.

#### Substitute Transportation

Substitute Transportation Coverage reimbursement available for eligible breakdowns with receipt from valid rental agency. See your service agreement for eligibility requirements and for coverage amounts per occurrence.

#### Towing Assistance

If towing becomes necessary due to a breakdown of a covered component, actual towing costs, not payable by insurance, will be covered up to \$350.

#### Transferability

For added resale value, your coverage can be trans-ferred to a new owner, should you decide to sell your recreational vehicle.
